1. Chairman's Report (Ken Kirby)

Only one competition attended last year - Manchester Octopush Tournament (MOT). No trip to Berck, France as their pool was being refurbished. Numbers are still low, but we did manage to attract one new member & an ex member re joined.

We produced a new poster for display in Crown Pools to attract new members. This cost £100. So far this poster has resulted in a number of enquiries, but no new members yet.

It is now a requirement that we have a 'responsible adult' at each pool session in case of incidents. It will be their job to write a report of the events.

2. Treasurer's Report – Accounts & discussion of fees for next year (Charlie Simms)

Charlie went through the accounts & it was clear that the continued low membership over the past few years has affected the ability of the club to pay for our pool sessions. The club made a loss of ~£600 last year which equates to 2 full members! The club reserves stand at ~£5,000. A copy of the accounts will be emailed out to members along with these minutes. It was recommended that the membership should cover the cost of the pool hire to ensure that the club is not left out of pocket again. The projected pool fees for this coming year coupled with the membership fees at their current rate will mean that the club will make a loss of £961 next year. Obviously this is not sustainable. There then followed then a detailed discussion on how the membership fees should be increased & on the types of membership that should be offered.

Initially there were 3 proposals that were voted on. The one with the least number of votes was then rejected & another vote cast on the remaining two options:

Option 1 carried 10 for, 2 against.

These price rises will take affect from the 1st July 2008. Please ensure that your standing orders are updated accordingly and are also paid by the 5th of the month to help the treasurer track payments.

We then discussed the 'visitors' pool fee. There was concern that some members might reduce their membership & just pay the £5 per session fee so it was proposed to also include an annual membership fee as well.

It was proposed that any member attending the pool sessions for more than one month that the 'per session visitors pool fee' should remain at £5, but that an annual membership fee of £50 be payable which will include the BOA membership & insurance – Carried Unanimously

"If we are unable to increase the membership by next year it is likely that the membership fees will need to go up to £30 a month so it is in the interest of all members to assist in whatever way they can to increase the number of members."

This still holds true - the club needs to find more members.

It was also felt that it should be stressed that the membership fee is an ANNUAL one that members are allowed to pay monthly and that monthly payments cannot be 'missed' due to holidays etc.
